Robert Fehnel made a motion to approve the May 3, 2022 minutes. The motion was seconded by Andrew Rossi with the motion passing by a vote of 4-0.

22-11 7:00 p.m. 2500 Nazareth Road (Dunkin' Donuts), Tracey Diehl from Expedite The Diehl is seeking a variance from section 190-189 to replace an existing menu board with a static digital menu board. This property is in a General Commercial Residential Zoning District.

- **22-12 7:10 p.m.** Parcel L9-17-1P located on Kunkle Dr., Spyros Lenas, Jr. from Soaring Car Wash, is seeking variances from the following sections to build a low impact car wash facility within a Planned Office/Business zoning district.
- -190-168.H.(2). to have portion of the parking lot that encroaches into a landscape area along the Knukle Drive side of the lot.
- -190-168.G.(3). to have parking spaces that are 4.7 feet from a non-residential building, a minimum of 10 feet is required.
- -190-176.A. to have a freestanding sign that is 1.8 feet from the property line, a minimum of 5' is required.
- -190-185.B.(4). to have 2 wall signs, each with a sign area of 53.75 square feet that would be placed higher than 10 feet above the average adjacent grade.
- -190-185.B.(7). to have a 79.3 square foot monument sign that would exceed the 50 square foot maximum.
- -190-183.A. to have a freestanding sign that exceeds 5 feet in height, an 8 foot 10 inch tall sign is being proposed.
- -190-189.B. to have a 16 square foot electronic message sign that would be part of the proposed freestanding sign.
